Letter from the Nominating Committee

Dear congregation,

As we approach our upcoming Annual Meeting, the Nominating Committee would like to clarify our role in the nomination process and the decisions that we made this year.

The Nominating Committee is comprised of 12 members selected by the Deacons of the church and approved by the congregation. Our primary task is to consider and interview members of our congregation who are willing to stand as elders, moderator elect, and officers, to determine a) if they meet the biblical qualifications that are set out most clearly in Titus and 1 Timothy and b) if they would be the right fit for the current needs of the church.

We began the process in early April 2023, with a request for nominations from the congregation, through weekly announcements and the church bulletin, the ministerial staff, members of the Board of Elders, and Deacons. We carefully considered each nominee, paying particular attention to those whose names had been submitted multiple times. We reached out to a select list of candidates and asked them to prayerfully consider serving. If they were led to go forward with the process, they responded to an extensive questionnaire (covering the candidate's personal walk with God, ministry, leadership skills, Christian witness, understanding of the vision of the church, spiritual gifts, character and how these aspects fit within the needs of the church for this term). Candidates then attended an interview with the Nominating Committee. The committee also reached out to at least two references (at least one from within PSC and one from outside) with an extensive set of questions. As part of the process, candidates are asked to affirm **PSC's statement of faith, covenant of faith and government, and all positional statements.** 

The vetting process was carefully and diligently conducted with extensive times of prayer, discussion, and reflection. After lengthy deliberation, we voted (by secret ballot). The candidates that we nominated received unanimous or overwhelming support from the committee. We stand behind and strongly recommend the candidates we have nominated. However, it has become more common in the past few years for candidates who have not been nominated by the Committee to accept a petitionary nomination from twelve members of the congregation. We understand that a petitionary nomination is permitted by the bylaws. While it is impossible to fully disclose the entire reasons we made our decisions, it would be irresponsible for us not to inform the congregation of our determination that the two members whom we interviewed and overwhelmingly decided against have now been put forward as petitionary nominees. It is also important to clarify that the remaining petitionary names did not go through the same extensive interview process as the slate we put forward. Therefore, the Nominating Committee is not able to endorse those candidates.

We are thankful for the new slate of nominees that we have put forward for the congregation. We believe that they will lead our church well, and we look forward to how God will use them to lead our congregation for His glory and our good.

#### Julie Halvorsen, Candidate for Elder

#### Note...

#### Geoffrey Raux, Candidate for Moderator-Elect (2025)

- Geoff served as Deacon of Communion at PSC for many years, chaired the Nominating Committee, led Bible studies for nearly 25 years, and currently serves on the Board of Elders.
- Having come to know the Lord at an early age, he has cultivated a deep desire to serve the Lord, and to see PSC be united and thrive in this city. He has been a member of PSC since 2009.
